## **SAC Funds Balances**

-Over a hundred  $8^{th}$  grade students will be recognized tomorrow on 5/15/24. Gradtastic will take place this Friday on 5/17/24, and next week on 5/22/24 will be  $8^{th}$  grade "Fun Day". This will be a final chance for  $8^{th}$  graders to be together and have a good time!

-Mrs. Jacobson presented result responses of the SAC Parent Needs Assessment. Mrs. Jacobson presented the data highlighting some positive results in students feeling safe at school, students feeling academically challenged, and building good character. Areas of improvement for FCM is working on eliminating frustration with Schoology and having more consistency with how teachers use Schoology. Another area of improvement is to offer different clubs to meet all interests of the full student body. FCM is committed to adjusting according to the feedback of parents.

-B. Ernsting mentioned she can't call the last time she looked at Schoology and that she puts that responsibility on her child. Mrs. Jacobson responded with the notion that the release of responsibility as students age is important, but Schoology is beneficial for both parents and students.
